## How to Avoid Vaccination.

Parents, when **REGISTERING** births, will find on the front page of the Paper given them a form of declaration of conscientious objection, which they must **FILL IN**.

Then the **FATHER** must **TAKE THE FORM** to a Commissioner for Oaths, or a Justice of the Peace, or Stipendiary. This Declaration must be made within four months of the birth of the child. It is useless if made later.

**WHEN THE DECLARATION HAS BEEN SIGNED** by the Magistrate or Commissioner, **POST IT IMMEDIATELY TO YOUR VACCINATION OFFICER**. It will be **OF NO USE** unless he gets it **WITHIN SEVEN DAYS** after its signature. It is not necessary that application be made at a Police Court; most Solicitors are Commissioners, and will take your declaration. **Many Magistrates will sign the declaration privately, when no fee can be charged.**

# Still Get Polio in Epidemics!

AFTER FOUR YEARS of Salk polio prevention vaccinations on a nationwide scale, infantile paralysis, especially the paralytic form, in 1959 nearly doubled the 1958 rate. In some areas, it ran eight times higher than the 1958 rate.

Just prior to last summer's polio epidemic, the U. S. Public Health Service had reported that the Salk vaccine had "wiped out polio 80 to 100 per cent."

To the contrary, the serum has caused polio. In Iowa, last summer's polio epidemic was proven to have been caused by Salk shots — two-thirds of the victims had them. In Des Moines, Iowa, for instance, Mrs. Aileen Jesse had her three children inoculated three times. Shortly afterward, they developed polio. Then her family doctor frightened her into taking the three shots; after the first one, she contracted bulbar

one Tennessee mother fell into the hands of the law for refusing to have her children vaccinated. In well-"Salked" North Carolina, polio in 1959 reached epidemic proportions.

In South Carolina, Richland County's chairman of the School District No. 1. Board of Directors, Dr. Hayward Gibbes, answered the National March of Dimes' demand that all children be "Salked." He said that the Salk serum's status is not such that mandatory inoculation is justified.

The Salk vaccine resulted from experiments financed largely by the Rockefeller Foundation. The Drug Trust of manufacturing companies are controlled by the Rothschild and Rockefeller interests. Benefits to the Drug Trust show up quickly when profits from the sale of the Salk vaccine are examined. Eli Lilly's profits increased from \$11,-

211,391 in 1954 to \$38,617,510 in 1957; Parke-Davis—\$10,493,502 in 1954 to \$27,929,887 in 1957; Allied Laboratories—\$1,019,242 in 1954 to \$3,612,183 in 1957.

THAT Salk "monkey juice" is not all it could be is reflected in the many tests being administered in Europe, Asia and Central America of oral live virus polio pills.

Now live virus polio pills are being recommended, are said to be cheaper than the Salk serum. How cheap and how diabolical oral live virus polio inoculation may be is seen in a statement by Dr. Henry M. Gelfand in *The Journal* of the American Medical Association, released in August, 1959. He is a member of the Tulane University School of Medicine's Tropical Medicine and Public Health Department Division of Epidemiology. He suggested that live virus polio vaccine, given orally to a part of the

population, "might result in the effective vaccination of the entire population. This would be vaccine-induced 'herd-protection' of a level not yet achieved with any immunizing agent."

This suggestion is based on evidence—from 56 test cases—that the immunity gained from the vaccine could be passed from one person to another—that is, the live virus would spread from the inoculated person to others in close contact with him!

All overlook the obvious—which is not favored by the Rothschild and Rockefeller interests—that the best insurance against polio is a well-balanced diet, one free from the congesting sugars found in soft drinks, ice creams and other summer "hot weather" foods.

Informed people believe that polio shots and fluoridation are being used to weaken and enslave the people.

## Medical Establishment Declares War

New tactics used in battle *against* freedom of choice in health care

Those who are attempting to eliminate effective competition to the medical establishment pursue this goal far beneath the level of perception of most Americans. They have two ongoing initiatives. One of them, functioning through the influence of the World Trade Organization, has as its objective limiting our access to dietary supplements. The other, functioning through state medical boards, has as its objective the inactivation of medical doctors and other medical practitioners who provide alternative therapies not covered by the standards of care.

If these two initiatives are successful there will be little hope of stemming the continuing carnage which has made iatrogenic, or medically caused, disease a leading cause of death—100,000 deaths yearly from prescribed FDA-approved drugs alone according to the medical journals—or the continuing escalation of medical care expenditures which is adversely affecting families, businesses and government.

Rep. Ron Paul (R-Tex.), himself an M.D., has been consistently in favor of freedom of choice in health care and has introduced bills to make this freedom part of the law of the land. But the majority of his colleagues haven't evinced much interest in this initiative. It could be that they are more interested in cam-

paign contributions from the medical establishment than the welfare of the voters who put them in office.

Jonathon Wright, M.D., recently disclosed the plight of physicians offering alternative medical procedures in Washington. The Washington State Quality Assurance Commission (WSQAC) is spearheading an attack on approximately 33% of physicians practicing alternative medicine in that state. In one case, a Dr. Geoff Ames was charged with moral turpitude because, according to the WSQAC, his offer of electro-acupuncture supplemented with dietary changes to correct a patient's food allergies, which the patient refused, was "ineffectual" and potentially harmful.

The charge of moral turpitude for suggesting a treatment with a high probability of providing the patient with a solution to his problem seems bizarre. The so-called "Nambudripad treatment" for food allergies, which is named after Dr. Devi S. Nambudripad and involves acupuncture, has been reported to eliminate food allergies and it is not far removed from electro-acupuncture in practice. I have experienced the Nambudripad technique. It quickly eliminated my allergic reaction to oak pollen.

Dr. Ames fought the charges and the 5 year suspension of license unsuccessfully and had to mortgage his home in order to pay for legal services—a tribute to the high costs of "justice." The medical establishment is fond of bankrupting its adversaries. ♥
